- I understand that numerous criteria exist for all financial aid programs and sources, including federal, state, military, veterans, and employer tuition assistance. Verification of data submitted on the FAFSA, determination of residency/domicile, course load and semester factors, program and student eligibility, borrowing history, lifetime Pell limits, and other regulations must be evaluated on an ongoing basis, and may alter my eligibility for aid.

- I understand that I will be responsible for any and all legal collection costs if I fail to keep my commitment to Bluefield College.
